We know the importance of educationof lessons that begin early and last a lifetime.

School is just the start.

We not only help keep girls in school, but we support them to build their confidence, gain skills and know their rights so they can follow their dreams.

Educating girls is more than just school work. It shows them that poverty isn't a life sentence. Self-worth. Independence. Equality. Empowerment. They're the most valuable lessons – and today you can pass that on to children everywhere.

HOW WILL YOU MAKE YOUR MARK ON THE WORLD?

Leaving a gift in your Will to a cause that's close to your heart is easier than you might think. If creating a world where all children can learn and break out of poverty is important to you, we'd love you to consider including a gift to Plan International Australia.

No matter how large or small, your gift will make the kind of impact for children that may never have been possible during their lifetime.

There are several different types of bequests and we suggest you seek the advice of a solicitor when making your Will. They can help make sure your Will reflects your intentions.

A solicitor may talk to you about the following options:

Residual gift: This gift is the remainder of your estate or percentage thereof after your loved ones have been provided for and expenses have been deducted. This is the type of gift we usually recommend because inflation doesn't erode the value of your bequest and it allows you to take care of your family first, while maximising the impact you can create for children around the world.

Percentage gift: This gift is used if you wish to divide your estate among a number of people or organisations. Leaving your gift as a percentage rather than a fixed amount also ensures that inflation doesn't erode the value and the impact of your gift over time.

If you have any other questions or a specific way you would like to leave a gift, please get in touch. We're always ready to help you with this very important – and very personal – decision.

- Leaving a legacy is your decision and yours alone. We understand the decision is a personal one and you can choose to change your mind at any time.

- If you do decide to tell us that you intend to leave a gift, we'll keep you updated on our work, in ways that suit you best.

Frouke de Reuver has always had a lot of empathy and cares about other people, especially children, which she attributes to the way she was raised. She grew up listening to stories of how her mother's family had hidden Jewish children in their home during World War II.

"My mother had a very strong social ethic and she was very caring," says Frouke. "She passed on a sense of 'this is just what you do'."

As a former teacher and child sponsor for almost 40 years, Frouke said it made sense to leave a gift in her Will to Plan International Australia – and her family completely supports her choice.

"We all share the same ethics and values, which makes it very easy. And again, that came partly from my mother ... [My family] will appreciate my money, but there is enough to support my key areas of passion. They are certainly happy that I am doing it."

When you educate a girl, you're not just changing her life or the life of her future children. You also change the life of others in her community, because she shows by example how – with the right support – anyone can be the first of their generation to be free, safe and equal.

This is the case for Lumasha, a mother of two from Kenya, who came into contact with the Girls Advocacy Alliance (GAA) – a program supported by Plan International that helps girls stand up for their rights.

"It's no exaggeration to say that this group saved my life," Lumasha says. "For the first time ever, I dared to speak up about my horrible experiences."

Lumasha grew up experiencing violence and, after being forced to drop out of school at just 13, was married to a violent man.

It was all she knew; all she expected from life. But after attending the GAA,

Lumasha gained new life skills and understood a different life was possible. She also realised she had the power to give her daughter an education, opportunities and a safe home.

"Thanks to these training sessions, along with the skills I have learnt, I no longer need a husband," she says. She enrolled in a Plan International-supported seamstress course so she could become financially independent and pay for her daughters to go to school.

"My main purpose in life now is to give my daughters a better childhood than I had. Thanks to this training, I can look forward to the future with confidence and hope".

This is the power of your support. By leaving a gift in your Will, you are helping create a world where girls can stay in school, get married when they choose, find meaningful work, have a say in their communities and be free from fear and violence.



When a bequest is realised, some of the funds are expended straight away to achieve impact for girls and their communities.



A portion of your bequest will be invested in a fund that is specifically set up to grow core capital. This will help us generate long term income, which is critical to make sure our programs are secure and sustainable.


Changing the world for the next generation of girls *is* possible.
